“Many of our customers have been asking when they could buy a solution for fire and emergency services that was as good as our law enforcement product, so this was a logical market for us to enter,” explained George Lieberman, CEO of Enforsys. “ESP is a well-respected leader in the space, and will help us get closer to our goal of empowering public safety by being the leading provider of public safety software.”

In addition to fulfilling a broader range of customer needs and increasing potential market, ESP will provide Enforsys with significant strategic benefits. “Data from ESP will add intelligence to the Enforsys I-3 Exchange information sharing system, and on the financial side the acquisition will allow for increased investment in R&D, technology and CRM,” Lieberman explained. He added that this marks Enforsys' third acquisition in 2005.
